NOTABLE PROJECTS

Western Lake Erie Basin Watershed – Nutrient Source Inventory | City of Toledo and Lucas County, OH

CEC is working to achieve nutrient load reductions and reduce harmful algal blooms in the Western Lake Erie Basin. The first phase of this project included identifying nutrient sources within the watershed and creating a publicly available Geographic Information System (GIS)-based tool for database management and development of interactive maps. CEC will be assisting with the next project phase: additional inventory and mapping activities, as well as modeling of the entire watershed..

Harroun Park Stream Restoration | Sylvania, OH

CEC assisted the City of Sylvania with stabilizing Tenmile Creek, a highly channelized stream causing eroding stream banks and contributing to high sediment and nutrient loads flowing to Lake Erie. After the City extended a public walking trail within Harroun Park, it needed to stabilize the stream banks to help protect adjacent infrastructure and erosion that was also contributing to in-stream habitat loss. CEC secured grant funding; designed the restoration improvement; obtained permits from the U.S. Army Corps of Engineers, Federal Emergency Management Agency, and the Ohio Environmental Protection Agency; and provided construction management services.

Formerly Utilized Sites Remedial Action Program (FUSRAP) Remediation Project | Luckey, OH

This site was identified as having materials contaminated with beryllium, lead, radium-226, thorium-230, uranium-234, and uranium-238. CEC is assisting with managing stormwater through the initial stages of remediation. CEC revised the Stormwater Pollution Prevention Plan (SWPPP) and began to provide weekly and post-rain-event SWPPP inspections. We provided a pre-excavation survey using drones and LiDAR technology and began providing weekly excavation surveys in the exclusion zone.

Williams County Landfill | Bryan, OH

CEC has provided compliance monitoring since 2011, and took over engineering assistance in 2015. CEC prepared a Permit-To-Install (PTI) Alteration Request; following approval, CEC provided design, bid support, materials prequalification, and construction phase services for the construction of 5.6 acres of best available technology (BAT) final cover and 3.2 acres of BAT separatory liner.
